Some books I don't have much to say about. This one, while not bad, it wasn't an adrenaline rush or anything. Joe Dillard won the case far too easily like the opposing counsel was inept. Doesn't make for a compelling read.- 3 stars

I didn't find myself particularly intrigued by this one. If I missed a bit, I didn't find myself caring all that much. I have a difficult enough time in my belief of psychics but when telekinesis is introduced, well, that just stretches the imagination to another proportion. I think the author might have used the wrong word though because telekinesis is the ability to move objects but that didn't seem to be the case. In any event, the certain ability that one character was said to have had, still stretches the imagination to the extreme.

I'm a bit dumbfounded over the non-use of ballistics when clearly, in real-life, it would have been used.
