South Dakota author Karen Hall brings a good deal of professional expertise and knowledge to her debut novel. She's a trained environmental engineer. She understands, presumably, the considerable advantages of the industrial complex that powers the nation. She also understands the risks inherent in the concentration of volatile materials in a place like an oil refinery.

Hannah Morrison understands the risks and rewards all too well, as well as the unwelcoming mostly male environment of this particular refinery on the edge of the Mississippi River in Minnesota, where a big part of her job is to oversee environmental controls. Fires at oil refineries are not unknown and when a fire emergency results in serious injury of her fire-fighting partner, she is emotionally devastated. To add to her troubles, there are repeated suggestions that sloppy maintenance caused the fire and fingers are pointing in her direction.

Digging into the cause of the fire and some other related information leads Hannah step by step into the realization that somebody is bent on sabotaging the refinery. Now it becomes a race between Hannah and her adversaries as she tries to unmask the killers before they murder her and destroy the refinery.

This thriller is a carefully crafted, smoothly written debut about an environment that has largely escaped the attention of crime fiction writers. Our protagonist is a well imagined bright woman with normal strengths and fears, yet one who perseveres in ways we hope we would too. Hall knows her stuff and is a good writer. I recommend this thoughtful gripping novel.

I read this book quite a few months ago and apparently failed to review it (or at least to post the review!) in any of my usual places. I read this as the Minnesota entry in my A Mystery for Every State project. It's set at an oil refinery/tank farm much like the one in Rosemount, south of the Twin Cities. The protagonist is a sort of risk manager for the refinery -- she's an engineer, but her main concern is making sure nothing awful happens. One of her problems is that a local NIMBY group is up in arms about the refinery (which was already there when they built their houses). Another is that she's fairly new in town and lonesome. And then, things start going wrong, and she believes it's sabotage. Plus, someone is sending her unpleasant messages. Into all this comes an engaging TV reporter -- can she trust him or not?
